- Employees shall be granted two (2) step advancements on the 2011-2012 salary schedule.
- Approved column advancement shall be permitted for eligible employees for the 2011-2012 salary placement.
- Employees shall be granted two (2) step advancements not to exceed Step 5 on the 2011-2012 differential salary schedule. One point four three percent (1.43%) will also be added to those receiving a fixed differential stipend.
- One point four three percent (1.43%) was added to the base to offset the employee contribution to the Wyoming Retirement System. Those off the salary schedule shall also receive the one point four three percent (1.43%) offset. Six dollars (\$6) was added to Step 1 to make a even dollar base at the entry level salary.
