Example: Jane Smith, a teacher, has completed 5 years of full time service for the NYC DOE. She is currently on Salary Step 6A and holds the first and promotional differentials. Her annual salary as of 5/1/2016 is \$61,674. Her new salary code is 6V and her new annual salary is \$62,762 which includes the \$1,088.
