PLEASE NOTE: Health care premiums are pre-tax, prepaid, for an entire month, without proration. Example: October premiums are paid with the September payroll deductions. If the paperwork is not processed until 2nd pay period of the month, additional deductions will be pulled on future paychecks to obtain the missed deduction from the 1st pay period of the month. The same will be done for dental and vision plans as well.

NORFOLK PUBLIC SCHOOLS WELLNESS REDUCTION RATES

If you have chosen to participate in the wellness program and completed the credit criteria in 2021, you will receive an annual health insurance premium reduction credit of \$120 in 2022, divided by 20 pay periods which is \$6 per pay period. Although you were not required to complete any of the credit criteria tasks, employees who did so will receive the incentive as reflected in the Wellness Rates listed in the table below.
