

The district confirmed that on the 2014-2015 salary schedule, teachers holding a MA begin two steps higher than their experience warrants (e.g., a teacher with no experience begins on Step 3), and that there is no additional pay for other advanced degrees (e.g., PhD). Given that the 2014-2015, 2015-2016, 2016-2017 and 2017-2018 salary schedules are all contained in the same document, we are assuming that in 2017-2018 there is no additional pay for advanced degrees and that teachers holding a MA will begin two steps higher than their experience warrants.
