

Teacher Performance

Teacher performance is determined by using the Teacher Performance Evaluation Rubric consisting of indicators based on the Ohio Standards for the Teaching Profession (/getattachment/Topics/Teaching/Educator-Evaluation-System/Ohio-s-Teacher-Evaluation-System/Teacher-Performance-Ratings/Rev_TeachingProfession_aug10.pdf.aspx). The evaluation process requires the evaluator to use evidence gathered in a variety of avenues (professional growth or improvement plan, observations, walkthroughs, and conferences) to determine a teacher performance rating. The diagram below (11/25/15) displays the sequence of activities teachers and credentialed evaluators will follow throughout the year.
