## **NEW MEXICO TEACHER PREPARATION IS NOT ALIGNED WITH COLLEGE- AND CAREER-READINESS STANDARDS**

**New Mexico's teacher preparation policies fail to ensure that new teachers are ready to help students achieve to the high levels necessary for college and careers.**

December 10, 2014 (Washington, DC) — The National Council on Teacher Quality (NCTQ) today released its eighth annual *State Teacher Policy Yearbook*. This year's edition focuses on New Mexico's efforts to align its requirements for teacher preparation and licensure with the skills needed to prepare students for college and careers.

NCTQ Vice President and Managing Director for State Policy Sandi Jacobs said, "With such a profound change occurring in K-12 student standards across the country, it would stand to reason that parallel changes would occur on the teacher side. New Mexico needs to ensure that teachers are adequately supported in the transition and beyond. And there is no better place to start than where new teachers begin to learn their craft—in teacher preparation programs."

### **Key Yearbook Findings:**

#### **New Mexico's teacher requirements are not explicit about preparing teachers for college- and career-readiness standards.**

- New Mexico's standards for new teachers don't sufficiently articulate the instructional requirements of college- and career-readiness standards, such as using informational texts, cross-disciplinary literacy, and intervention for struggling readers.

#### **State content knowledge requirements for prospective teachers in New Mexico aren't ambitious enough to meet the demands of college- and career-readiness standards.**

- New Mexico does not require elementary teaching candidates to pass a content test that provides separate scores for all core subject areas, making it difficult to ensure elementary teachers have mastered all of the content they are licensed to teach.
- New Mexico is one of 18 states that ensures prospective teachers demonstrate their knowledge of the science of reading. Unfortunately, however, the state does not require that special education teachers or early childhood teachers teaching in the elementary grades know the science of reading.
- New Mexico is one of 14 states that issues a K-8 teaching license, which fails to differentiate between the preparation of elementary teachers and middle school teachers.
- New Mexico, along with 37 other states, has significant loopholes in its licensing requirements for high school teachers.

**The preparation needs of special education teachers continues to be a largely neglected area, with the introduction of more challenging academic standards in New Mexico having little to no impact on requirements for teachers who educate special education students.**

- New Mexico is one of 34 states in the nation that still offers or exclusively grants K-12 special education teacher licenses. In addition, New Mexico does not require special education teachers to demonstrate subject matter knowledge as a condition of licensure.

**New Mexico's teacher preparation admissions requirements are not selective.**

- With no minimum GPA or test of academic proficiency required for admission to teacher preparation programs, New Mexico sets a low bar for the academic performance of the state's prospective teachers.

**Although it has announced its intention to revise these policies, at present New Mexico neither collects meaningful data about the quality of teacher prep programs nor holds programs accountable for the quality of the teachers they produce.**

- New Mexico is one of 41 states that does not connect student achievement data to teacher preparation programs.
- New Mexico does not set explicit minimum performance standards for teacher preparation programs in the state.

**Looking at NCTQ's traditional *Yearbook* metrics, New Mexico earns an overall grade of D+ for teacher preparation.**

- The average grade for all states for teacher preparation in 2014 is a C, up from a D in 2011.
