WEST VIRGINIA KEEPS PACE WITH OTHER STATES ON TEACHER EFFECTIVENESS POLICY OVERALL; BUT STATE EFFORTS ARE UNEVEN

New Report from NCTQ Finds West Virginia Could Do More to Consistently Enact Policies that Support Effective Teaching; State Earns C-

December 8, 2015 (West Virginia, DC) — The National Council on Teacher Quality today released its ninth annual *State Teacher Policy Yearbook*, which includes a 360-degree analysis of every state law, rule and regulation that shapes the effectiveness of the teaching profession in West Virginia.

West Virginia received an overall grade of C-, which is the same as the average grade for 2015 across all 50 states and the District of Columbia.

NCTQ Senior Vice President for State and District Policy Sandi Jacobs said, "Nationwide the glass is

really starting to look half full on states' efforts to drive teacher effectiveness through smarter policy. Like most states, however, West Virginia has plenty of room for improvement."

On teacher preparation and licensing, West Virginia's policies help ensure teachers are prepared for the demands of college- and career-readiness standards:

- *Admission requirements*. West Virginia requires that teacher preparation programs admit candidates with strong academic records.
- *Elementary teacher preparation*. West Virginia's content tests for elementary school licensure provide separate passing scores for each subject which helps ensure teachers know all of the core content they will teach.
- *Middle school licensing*. West Virginia does not offer a generalist K-8 license and requires middle school teachers to pass a content test in each subject they will teach.
- Special education. West Virginia is one of 14 states that, appropriately, does not offer a K-12 general license for special education teachers, a license that wrongly presumes special education teachers do not need to master grade and subject specific content knowledge.
- *Science of reading*. West Virginia requires early childhood and elementary teachers to demonstrate knowledge of effective reading instruction.

While West Virginia ties teacher performance to some policy and practice, it does not require evaluations that are significantly informed by teacher effectiveness:

- *Teacher evaluation*. West Virginia requires annual evaluations but only requires some objective measures of student achievement/growth to be included.
- *Dismissing ineffective teachers*. West Virginia articulates that classroom ineffectiveness is grounds for a teacher's dismissal.

- *Professional support*. West Virginia requires that all teachers receive feedback on their evaluations requires, specifies that evaluations must inform professional development for all teachers and requires that teachers with poor ratings have structured improvement plans.
- *Tying performance to tenure*. However, tenure decisions in West Virginia are made virtually automatically after three years, without evidence of teacher performance.
- *Prohibiting "last in, first out" policies*. West Virginia also does not require districts to consider teacher performance (rather than only seniority) in making layoff decisions.

West Virginia has room to improve on other several critical teacher policy fronts:

- *Teacher prep accountability*. West Virginia collects performance data on teacher preparation programs but does not set minimum program performance standards or connect student achievement to teacher preparation programs.
- Support for performance pay. West Virginia does not support performance pay, although it does support differential pay for teaching in high-needs schools or shortage-subject areas. Unfortunately, West Virginia is also one of 15 states in the nation that still require additional pay for teachers with advanced degrees, despite the fact that research does not show that advanced degrees have an impact on teacher effectiveness.
- Alternate routes. West Virginia's alternate routes are in need of significant improvement.
